

## NMIMS School of Law – FAQs for UG programs

- 1. How many campuses does the NMIMS School of Law have?
  - > The school has 5 campuses across India:
    - i. Kirit P. Mehta School of Law, Mumbai
    - ii. School of Law, Navi Mumbai
    - iii. School of Law, Indore
    - iv. School of Law, Hyderabad
    - v. School of Law, Bengaluru.
  - We are starting with 2 more campuses in 2020:
    - i. School of Law, Chandigarh
    - ii. School of Law, Dhule
- 2. How old is the school?
  - Mumbai campus 7-year-old
  - Navi Mumbai 3-year-old
  - Bengaluru 2-year-old
  - ➢ Hyderabad − 2-year-old
  - Indore 2-year-old
- 3. Do all the campuses have the same course structure and pedagogy?
  - The course structure, pedagogy, curriculum, infrastructure & facilities are the same across all the campuses.
- 4. What is the eligibility criteria for B.A. LL.B. / B.B.A. LL.B. program?
  - To apply for these courses the student should have passed in the 12<sup>th</sup> grade examination conducted by a recognized board / university with minimum 50% marks.
  - CLAT / LSAT Score
- 5. What is the admission process for B.A. LL.B. / B.B.A. LL.B. program?

The candidate can log onto – <u>www.law.nmims.edu</u>. After selecting their preferred course, they need to fill in the application form with their personal and academic details. The final step is to fill in their CLAT and / or LSAT score followed by making the payment.

\*The form can be edited to fill LSAT / CLAT / 12<sup>th</sup> grade marks once received. (Applicable for LL.B. & LL.M. programs)

- 6. Which entrance exam score does NMIMS School of Law accept?
  - NMIMS School of Law accepts both CLAT and LSAT Scores. A candidate can either apply though CLAT exam score or LSAT exam score or both the exam scores.
- 7. Which entrance exam is given more preference in the selection process?
  - We do not prefer any particular exam over the other. We have 2 separate merit lists for both the entrance exam.
- 8. Is Math a prerequisite for admission?
  - ≻ No.
- 9. Does NMIMS School of Law consider 12<sup>th</sup> grade marks in the selection process?
  - No. 12<sup>th</sup> grade marks are only the eligibility criteria for application at our law school. We do not consider the marks for admission process.

11. Does NMIMS School of Law provide direct admission?

No. Admission into NMIMS School of Law is solely based on merit. There is absolutely no quota system.

- **12.** What is the application fee?
  - The application fee is ₹1200 plus GST. The candidate does not have to pay any additional amount for selecting multiple program and campus preference.
- **13.** What is the fee for the undergraduate programs?
  - Mumbai Campus 2,01,500/- per annum (2019-2020 fee)\*
  - Navi Mumbai, Bengaluru, Hyderabad & Indore 1,01,500/- per annum (2019-2020 fee)\*
  - \*subject to change
- 14. Does the school have extracurricular activities for the students?
  - Yes, the school believes in holistic growth and gives equal importance to extra curriculum activities. A few co-curricular activities – Debate society, Moot court committee, Model United Nations Committee, etc. The extracurricular activities at our school are cultural & sports activities. The students participate in several events, competitions & festivals.
- **15.** How many alumni batches for the undergraduate program does the school currently have?
  - ➤ Kirit P. Mehta School of Law currently has 3 undergraduate alumni batches.
- 16. What is the placement statistics for the undergraduate programs?
  - We provide 100% placement assistance to all our students. In 2019 placements, we placed 76% of our students in law firms & corporates. 21% students went on to pursue their master's degree and the remaining 3% chose to practice law independently.
- 17. Does NMIMS School of Law provide internship opportunities?
  - Yes, for the undergraduate programs, internship is compulsory and credit based. The students have to complete 5 internships in their tenure. The linear progression of internship starts from NGOs to Trial Court, from Trial Court to High Court / Firms / Corporates and from High Court / Firms / Corporates to Supreme Court. School of Law provides internship assistance to learners as per their necessity.
- 18. What are the college timings for the undergraduate programs?
  - For 1<sup>st</sup> four semesters 8 AM to 4 PM
  - > 5<sup>th</sup> semester 8 AM to 10 AM
- 19. What does Honours program mean?
  - In an Honours program, the student gets to select an elective subject in the 4<sup>th</sup> year based on their interest & preference. Also, in this type of program the student has to complete a certain number of credits to receive the degree.

20. What is the last date of application for the undergraduate programs?

> The last date for application is 13<sup>th</sup> September 2020

- 1. What are the postgraduate courses offered by NMIMS School of Law?
  - > The school offers Master of Law (LL.M.) in 4 specializations:
    - i. Constitutional Law
    - ii. Corporate Law
    - iii. Financial Regulations, and
    - iv. Intellectual Property Rights
  - LL.M. is a one-year program offered only in our Mumbai campus.
- 2. What are the specializations available for the LL.M. program?
  - i) Constitutional Law
  - ii) Corporate Law
  - iii) Financial Regulations, and
  - iv) Intellectual Property Rights
- 3. What is the eligibility criteria for the LL.M. program?
  - The candidate should have passed in the examination conducted by a recognized University leading to the award of an LL.B. degree (minimum 50% in final year examinations).
- 4. What is the admission process for LL.M. program?
  - The candidate can log onto <u>www.law.nmims.edu</u>. After selecting their preferred course, they need to fill in the application form with their personal and academic details. The candidate can apply either through their PG CLAT score OR a written test & personal interview.
